WHEREAS, the City has further stated that it will no longer provide necessary maintenance services on the Out-City Users sanitary sewer lines, grinder pumps and grinder pump stations if a new intergovernmental wastewater agreement is not reached by September 1, 2016, and

WHEREAS, the parties are still in the midst of negotiations on the replacement contract and it is unlikely that a new agreement will be in place by the time of the City's unilaterally imposed September 1, 2016, deadline, and

WHEREAS, any interruption in the proper functioning of the wastewater treatment system, including proper maintenance of sanitary sewer lines, grinder pumps and grinder pump stations, would threaten the public health, safety and welfare of the residents of Bedford Township,

NOW, THEREFORE, BE IT RESOLVED, that the Charter Township of Bedford Board hereby authorizes the Township Supervisor to join with the other Out-City Users in seeking judicial protection, if necessary, to ensure the ongoing provision of wastewater treatment services, including necessary maintenance services on all sanitary sewer lines, grinder pumps and grinder pump stations located within the governmental jurisdiction of each Out-City User consistent with the terms of the 1985 Intergovernmental Wastewater Service Contract while the parties finalize their negotiations.
